Election of a representative of the University of Kerala from among the members of the Senate to the General Council of the Kerala Agricultural University

(Under Section 10- Other members (1) of the Kerala Agricultural University Act, 2001)

NOTIFICATION

It is hereby notified that an election will be held to elect a representative of the University of Kerala from among the members of the Senate to the General Council of the Kerala Agricultural University as required under Section 10 - Other Members (1) of the Kerala Agricultural University Act, 2001.

Only persons whose names are included in the electoral roll of members of the Senate published by the University on 28.12.2024 and subsequently modified on 06.01.2025 are eligible to take part in the election and to vote thereat subject to the provisions contained in the Kerala University Election Statutes.

Every elector is at liberty to nominate one duly qualified person to fill up the vacancy. Every such nomination shall be proposed by an elector and shall be seconded in writing by another elector. Every such nomination shall contain an affidavit and the consent of the nominee agreeing to serve the concerned body, if elected. Nominations should be made in the prescribed form, copies of which can be had from the Election Section, University Office, Thiruvananthapuram, free of cost, on request.

Nominations duly filled in, in all respects should reach the Registrar/Returning Officer not later than **03.00 p.m. on 21.01.2025**. Nominations if sent by post should be enclosed in an envelope superscribed "Nomination for election to the General Council of the Kerala Agricultural University".

The polling for the above election will be held from **8.30 a.m. to 10.00 a.m. on 04.02.2025** at the meeting of the Senate at the Senate Chamber, University Buildings, Thiruvananthapuram.
