Whereas the University, vide its notifications read as (1) above has notified election of Office-bearers, members of the Executive Committee and members of the Accounts Committee of the Kerala University Union from among the members of the General Council, 2023-2024, and (2) Election to the Senate, under section 17 - elected member 12 of the Kerala University Act, 1974, and to the Students' Council under section 29(2) - elected members of the Kerala University Act, 1974, by the Members of the General Council of the Kerala University Union, 2023-2024.
