Business brought forward by the Vice-Chancellor and the Syndicate.

01. Award of Degrees, Diplomas, Titles and Certificates. (C.E/D.D)

The Following resolution moved by Adv.Muralidharan Pillai G, Member, Syndicate and Convenor, Standing Committee of the Syndicate and seconded by Dr.K.G Gopchandran, Member, Syndicate was unanimously adopted by the House.
