1. The Bidder should be a company registered under the Companies Act, 1956 and in operation for at least 5 years as on 31.03.2022 and should have their registered office in Kerala.
2. Certificate of incorporation.
3. The company must be registered with appropriate authorities for all applicable statutory duties/taxes.
4. GST Identification number(GSTIN)
5. The Bidder shall be an authorized partner of the OEM
6. Manufacturer Authorization Form (MAF) from the OEM to be submitted by the bidder.

7. The Bidder should not be currently blacklisted by any Government/Government agency/Banks in India.
8. Self-declaration on not blacklisted to be submitted by the bidder.

General Conditions:

1. Those qualified in technical bid will be eligible for participating in financial bid. A presentation regarding the technical specification and item to be supplied shall be done before the technical evaluation committee if requested.
2. The bidder should be a manufacturer or their dealer specifically authorized by the manufacturer to quote on their behalf for this tender as per Manufacturer Authorization Form and Indian agents of foreign principals, if any, who must have designed, manufactured, tested and supplied the equipment(s) similar to the type specified in the “Technical Specification”. Such equipment must be of the most recent series/models incorporating the latest improvements in design.
3. **Compliance Statement:** Along with the technical details provide a tabular column indicating whether the equipment quoted by you meets the specifications by indicating 'YES' or 'NO'. If 'YES', support the claim by providing original brochures. **Venders should provide clear brochures/data sheets about the equipment and its working. Also include adequate proof for the claim regarding the performance.**
4. **Reference:** Names of Institutes with contact person and telephone/ email where similar items supplied by you in India [Preferably South India] shall be mentioned in the bid.
5. Incomplete & conditional tenders and tenders received after the due date will be summarily rejected without assigning any reasons thereof.
6. The price should be inclusive of all taxes, duties, transportation, insurance, installation etc. Nothing extra will be paid in addition to the quoted rate. Any amount in Indian rupees for installation, commission, labour, spares, service etc shall be entered in item 2 of BoQ.
7. **Payment Terms:** after the supply installation and commissioning of the items.

8. Validity of tender: Tender submitted shall remain valid at least for 120 days from the date of opening the tender. Validity beyond 120 days, from the date of opening of the tender shall be by mutual consent.
9. Delivery and installation: Proposed delivery schedule should be mentioned clearly. University of Kerala will provide customs duty exemption certificates if required.
10. Service facility: Supplier should mention their details of service setup and manpower in Thiruvananthapuram who are responsible for after sales support.
11. The model number, make, and a printed literature of the product shall submit positively.
12. In case of any dispute, the decision of the University authority shall be final and binding on the bidders.
13. The undersigned reserves the right to reject any or all of the tenders received without assigning any reason thereof.
14. If any component is found to be defective during the warranty period, the vendor has to replace the defective item immediately at their own cost.
